#### **ELECTION OF PARENT GOVERNOR**

We are writing to inform you that the term of office for one of our Parent Governors, Becky St John, expires in March 2020. In accordance with our instrument of government, we are therefore advertising this vacancy on the school's governing body. Becky has acted as the chair of the Curriculum, Teaching and Care committee and we would like to thank her for her service to date. The school has been fortunate to benefit from Becky's skill and professional expertise. Under the criteria detailed below, Becky is entitled to be elected for a second term of office.

You will be aware that governors play a key strategic role in the development of schools. The Board acts as a critical friend to the school, reviewing policies, monitoring best practice and value for money to ensure the curriculum is delivered in the best interests of the students. Governors also support the school in practical ways by offering advice through their own experiences or professions.

There is a full Board meeting once each half term throughout the year. Additionally, the Board has two committees:

- i) Finances, Premises and Personnel
- ii) Curriculum, Teaching and Care

Each committee meets at least once each half term to consider in detail the matters for which it is responsible. Every governor serves on the Full Board and on one committee. Governors also take individual responsibility for policies and for areas of the school. Policies are reviewed regularly by senior staff and governors working together on these revisions.

If you would like to stand for election please complete and return the form below to the school office by 3 pm on Tuesday 10 March 2020.

You will need to ask another parent of a student at the school to sign the form.

Please be aware that regulations require everyone elected or appointed to a governing body to undergo a pre-appointment check which will include a criminal background check. This is to ensure the safety of the students. If you are elected and you subsequently decline to undergo such a check, you will disqualify yourself.

Please give brief details about yourself (not more than 80 words) on the form. If an election is needed these details will be copied and sent to all parents with the ballot paper. Please note that the 80 word limit will be strictly enforced and result in additional wording being deleted.

If the number of nominations is the same as or less than the number of vacancies, then the parents nominated will be deemed elected unopposed. If there are not enough nominations, the governing body has the duty to appoint parent governors to fill the remaining vacancy/ies.

The governing body has determined that the term of office for a parent governor is 4 years. If you are elected you may serve the full term of office even if your child leaves the school before your term of office finishes.

If an election is necessary we will circulate a ballot paper following the nomination process.

Only parents of children registered at the school are entitled to stand or vote in the election. A parent who is paid to work at the school for more than 500 hours in a school year or is an elected member of the LA may not stand for election.

Each parent will have one vote per vacancy regardless of how many children they have at the school. The ballot will be secret and you will be notified of the result as soon as possible afterwards.

In most cases it will be obvious whether you are a parent. For the purpose of the election of a parent governor, a parent is:

Parents (including carers) of registered students at the school

"Parent" is defined for the purposes of the Constitution Regulations as including "any individual who has or has had parental responsibility for, or cares or has cared for, a child or young person under the age of 18". It includes a person who the child lives with or who looks after the child, irrespective of what their relationship is with the child. The reference in the definition must be someone involved in the full-time care of the child on a settled basis.
