## **Relationship to other policies**


This agreement relates most closely to the home learning, behaviour and attendance policies. It is also relevant to other school policies such as child protection and equality.

- support the school's policy and help prevent my child/children from signing up to services such as Facebook, Instagram, Snapchat and YouTube whilst they are underage (13+ years in most cases)
- close online accounts if I/we/teachers find that these accounts are active for my underage child/children
- read and respond, (if appropriate), to all communications sent out from the school, including the ebulletin. I will also regularly log on to the school's online system to access information about my child's attendance, behaviour, assessment data and other information relevant to my child's year group.
- Update the school promptly with any changes to contact details for any parent/carers and/or any changes which may affect my child, eg family/home circumstances
